# **CBHS Health Fund Limited June 6 Weeks Free Promotion TERMS AND CONDITIONS**

- Information on how to enter and register for the June 6 Weeks Free Promotion (Promotion) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions. This Promotion is not valid in conjunction with any other offer.
- 2. The promoter is CBHS Health Fund Limited ABN 87 087 648 717 of Level 5, 79 George Street, Parramatta, NSW, 2150 (**Promoter** or **CBHS**).
- 3. This promotion commences at 12:00am (AEDT) on 1 June 2019 and closes at 11:59pm (AEDT) on 30 June 2019 (**Promotion Period**).

#### **Definitions**

- 4. For the purpose of these Terms and Conditions:
  - a. CBHS Extras Cover means Top Extras, Intermediate Extras, Essential Extras or extras associated with FlexiSaver Package, KickStart Package, StepUp Package or Prestige Package as defined in the CBHS Health Benefit Fund Rules;
  - CBHS Hospital Cover means Comprehensive Hospital (Gold), Active Hospital (Silver Plus), Limited Hospital (Bronze Plus), Basic Plus Hospital or hospital cover associated with FlexiSaver (Basic Plus) Package, KickStart (Basic Plus) Package, StepUp (Bronze Plus) Package or Prestige (Gold) Package as defined in the CBHS Health Benefit Fund Rules;
  - a. Current Member means an existing member of CBHS.
  - Eligible Member means current and former employees, contractors and franchisees
    of the Commonwealth Bank of Australia Group and their partners and immediate
    family members including dependent and non-dependent children, siblings, parents

  - c. **Eligible Policy** means a current and financially active policy with CBHS that includes both CBHS Hospital Cover and CBHS Extras Cover;
  - d. **Eligible Applicant Gift or Gift** means six weeks free cover that is applied after the third month of cover held on an Eligible Policy.

## **Eligibility**

- 5. Entry is only open to residents of Australia aged 18 years or over and who are Eligible Members.
- 6. Employees of the Promoter and the Promoter's associated companies; participating retailers; and, agencies associated with this Promotion, are ineligible to enter.
