

# **CBHS Health Fund Limited June 6 Weeks Free Promotion TERMS AND CONDITIONS**

1. Information on how to enter and register for the June 6 Weeks Free Promotion (**Promotion**) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions. This Promotion is not valid in conjunction with any other offer.
2. The promoter is CBHS Health Fund Limited ABN 87 087 648 717 of Level 5, 79 George Street, Parramatta, NSW, 2150 (**Promoter** or **CBHS**).
3. This promotion commences at 12:00am (AEDT) on 1 June 2019 and closes at 11:59pm (AEDT) on 30 June 2019 (**Promotion Period**).

## **Definitions**

4. For the purpose of these Terms and Conditions:
  - a. **CBHS Extras Cover** means Top Extras, Intermediate Extras, Essential Extras or extras associated with FlexiSaver Package, KickStart Package, StepUp Package or Prestige Package as defined in the CBHS Health Benefit Fund Rules;
  - b. **CBHS Hospital Cover** means Comprehensive Hospital (Gold), Active Hospital (Silver Plus), Limited Hospital (Bronze Plus), Basic Plus Hospital or hospital cover associated with FlexiSaver (Basic Plus) Package, KickStart (Basic Plus) Package, StepUp (Bronze Plus) Package or Prestige (Gold) Package as defined in the CBHS Health Benefit Fund Rules;
  - a. **Current Member** means an existing member of CBHS.
  - b. **Eligible Member** means current and former employees, contractors and franchisees of the Commonwealth Bank of Australia Group and their partners and immediate family members - including dependent and non-dependent children, siblings, parents and grandchildren.   - c. **Eligible Policy** means a current and financially active policy with CBHS that includes both CBHS Hospital Cover and CBHS Extras Cover;
  - d. **Eligible Applicant Gift or Gift** means six weeks free cover that is applied after the third month of cover held on an Eligible Policy.

## **Eligibility**

5. Entry is only open to residents of Australia aged 18 years or over and who are Eligible Members.
6. Employees of the Promoter and the Promoter's associated companies; participating retailers; and, agencies associated with this Promotion, are ineligible to enter.
7. Entries submitted from outside Australia will not be considered.

## **The Promotion**

8. To be eligible to receive the Gift, applicants must:
  - a. not be a member of an Eligible Policy within the last 12 months;
  - b. be an Eligible Member;

  - d. join CBHS on an Eligible Policy within the Promotion Period;
  - e. acknowledge they agree to these Terms and Conditions and the CBHS Privacy Policy; and
  - f. follow any other reasonable directions provided by the Promoter in relation to the membership process

(hereafter referred to as **Eligible Applicant**).

9. An application to join CBHS which is received after the close of the Promotion Period will not be eligible.
10. Only one entry is permitted per household during the Promotion Period, as determined by the residential address linked to the Eligible Policy.

#### **Six Weeks Free**

10. To be eligible to receive Six Weeks Free, Eligible Applicants must register with CBHS during the Promotion Period and hold an Eligible Policy for 90 days after the Eligible Applicant joins CBHS on an Eligible Policy. Six Weeks Free cover is applied after the third month of cover held on an Eligible Policy.
11. Six weeks free cover is not transferable or exchangeable and cannot be taken as cash.

#### **General**

9. The Promoter reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the process or the operation of the Promotion. The Promoter reserves the right to verify the validity of each Eligible Applicant.

If this Promotion is interfered with in any way, or is unable to be conducted as anticipated as realistically expected due to any factor beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to modify, suspend, terminate or cancel the Promotion, as appropriate.
11. Any cost associated with accessing the Promoter's website for the purpose of entering this Promotion is the entrant's responsibility and is dependent on the internet service provider used. The Promoter makes no guarantee of the availability of its web services and will not be held responsible for interruption of service that may interfere with the ability to participate in the Promotion.

  - e. any tax liability incurred by the applicant; or
  - f. use of the Gift.

These Terms and Conditions must be read subject to those statutory provisions and will not affect any statutory rights that an entrant may have.
