TERMS AND CONDITIONS

1. Information on how to enter and register for the June 2 & 6 Months Waits Waived on Extras Plus One Month Free Promotion (**Promotion**) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions. This Promotion is not valid in conjunction with any other offer.
2. The promoter is CBHS Health Fund Limited ABN 87 087 648 717 of Level 5, 79 George Street, Parramatta, NSW, 2150 (**Promoter** or **CBHS**).
3. This promotion commences at 12:00am (AEST) on 1 June 2017 and closes at 11:59pm (AEST) on 30 June 2017 (**Promotion Period**).

Definitions

4. For the purpose of these Terms and Conditions:
 - a. **CBHS Extras Cover** means Top Extras, Intermediate Extras, Essential Extras or extras associated with FlexiSaver Package, KickStart Package, StepUp Package or Prestige Package as defined in the CBHS Health Benefit Fund Rules;
 - b. **CBHS Hospital Cover** means Comprehensive Hospital, Active Hospital, Limited Hospital, Basic Hospital or hospital cover associated with FlexiSaver Package, KickStart Package, StepUp Package or Prestige Package as defined in the CBHS Health Benefit Fund Rules;
 - c. **Eligible Member** means current and former employees, contractors and franchisees of the Commonwealth Bank of Australia Group, their partners and immediate family members and extended family members.  - d. **Eligible Policy** means a current and active policy with CBHS that includes both CBHS Hospital Cover and Extras Cover commencing concurrently during the Promotion Period;
 - e. **One Month Free** means the third month of cover held on an Eligible Policy;
 - f. **Waiting Periods** means the two and six month waiting periods which apply to CBHS Extras Cover.

Eligibility

5. Entry is only open to residents of Australia aged 18 years or over and who are Eligible Members.
6. Employees of the Promoter and the Promoter's associated companies; participating retailers; and, agencies associated with this Promotion, are ineligible to enter.
7. Entries submitted from outside Australia will not be considered.

The Promotion

 - a. not be a member of an Eligible Policy within the last 6 months or a spouse of a current CBHS Member;
 - b. be an Eligible Member;

 - d. join and commence payment of an Eligible Policy; and
 - e. follow any other reasonable directions provided by the Promoter in relation to the claim process,

(hereafter referred to as **Eligible Applicant**).
9. Entries received after the close of the Promotion Period will not be eligible.
10. Only one entry is permitted per household during the Promotion Period, as determined by the residential address linked to the Eligible Policy.

Waiting Periods and One Month Free

11. To be eligible to have the 2 & 6 month Waiting Periods on CBHS Extras Cover waived and One Month Free, an Eligible Applicant must hold an Eligible Policy for 90 consecutive days from the time they join an Eligible Policy. Excludes any waiting periods of more than 6 months and waiting periods on CBHS Hospital Cover.

General

12. The Promoter reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the process or the operation of the Promotion. The Promoter reserves the right to verify the validity of each Eligible Applicant.

If this Promotion is interfered with in any way, or is unable to be conducted as anticipated as realistically expected due to any factor beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to modify, suspend, terminate or cancel the Promotion, as appropriate.
