

**CBHS Health Fund Limited**  
**Can4Cancer 2 & 6 Months Waits Waived on Extras Promotion**  
**TERMS AND CONDITIONS**

1. Information on how to enter and register for the Can4Cancer 2 & 6 Months Waits Waived on Extras Promotion (**Promotion**) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions. This Promotion is not valid in conjunction with any other offer.
2. The promoter is CBHS Health Fund Limited ABN 87 087 648 717 of Level 5, 79 George Street, Parramatta, NSW, 2150 (**Promoter** or **CBHS**).
3. This promotion commences at 12:00am (AEST) on 1 September 2018 and closes at 11:59pm (AEST) on 31 October 2018 (**Promotion Period**).

**Definitions**

4. For the purpose of these Terms and Conditions:
  - a. **CBHS Extras Cover** means Top Extras, Intermediate Extras, Essential Extras or extras associated with FlexiSaver Package, KickStart Package, StepUp Package or Prestige Package as defined in the CBHS Health Benefit Fund Rules;
  - b. **CBHS Hospital Cover** means Comprehensive Hospital, Active Hospital, Limited Hospital, Basic Hospital or hospital cover associated with FlexiSaver Package, KickStart Package, StepUp Package or Prestige Package as defined in the CBHS Health Benefit Fund Rules;
  - c. **Donation** means an amount of \$100 payable by CBHS to the Tour de Cure Trust (ABN 56 302 713 357) for every new CBHS Membership which commences during the Promotion Period;
  - d. **Eligible Member** means current and former employees, contractors and franchisees of the Commonwealth Bank of Australia Group and their partners and immediate family members - including dependent and non-dependent children, siblings, parents and grandchildren.   - e. **Eligible Policy** means a current and active policy with CBHS that includes both CBHS Hospital Cover and CBHS Extras Cover commencing during the Promotion Period;
  - f. **Eligible Applicant Gift or Gift** means one GiftPay e-Gift Card (e-Gift Card) issued by Unified Incentives Pty Ltd ABN 53 157 818 427 t/as GiftPay (GiftPay) to the value of a \$100 eGift card if the Eligible Applicant joins online;
  - g. **Membership** means Single, Single Parent, Couple or Family Membership;
  - h. **Waiting Periods** means the 2 and 6 month waiting periods which usually apply to CBHS Extras Cover.

**Eligibility**

5. Entry is only open to residents of Australia aged 18 years or over and who are Eligible Members.

6. Employees of the Promoter and the Promoter's associated companies; participating retailers; and, agencies associated with this Promotion, are ineligible to enter.
7. Entries submitted from outside Australia will not be considered.

### **The Promotion**

8. To enter, applicants must, during the Promotion Period:
  - a. not be a member of an Eligible Policy within the last 12 months;
  - b. be an Eligible Member;
  - c. go to <http://www.cbhs.com.au/exclusive> and complete and lodge the application form with the code 'SPRING' prior to 11:59pm on 31 October 2018;
  - d. contact CBHS on 1300 136 796 and say the code 'SPRING' to a CBHS Member Care representative when you join CBHS over the phone;
  - e. acknowledge they agree to these Terms and Conditions and the CBHS Privacy Policy;
  - f. join CBHS on an Eligible Policy within the Promotion Period; and
  - g. follow any other reasonable directions provided by the Promoter in relation to the claim process, (hereafter referred to as **Eligible Applicant**).
9. Entries received after the close of the Promotion Period will not be eligible.
10. Only one entry is permitted per household during the Promotion Period, as determined by the residential address linked to the Eligible Policy.

### **Waived Extras Waiting Periods**

11. To be eligible to have the 2 and 6 month Waiting Periods on CBHS Extras Cover waived Eligible Applicants must join CBHS during the Promotion Period and hold an Eligible Policy for 90 days after they join CBHS. Any Waiting Periods more than 6 months, including Waiting Periods for Hospital or Pre-existing Conditions will continue to apply.
12. This waiver is not transferable or exchangeable and cannot be taken as cash.

### **Eligible Applicant Gift**

13. To be eligible to receive the Eligible Applicant Gift, the Eligible Applicant must join online within the Promotion Period and be active and paid up-to-date for a period of 90 days after the Eligible Applicant joins CBHS on an Eligible Policy.

### **Donation**

14. CBHS will make a collective Donation to the Tour De Cure Trust on behalf of every new Membership which joins on the Promotion and commences during the Promotion Period and is financially active as at 30 November 2018.
15. The Donation is not transferable or exchangeable and cannot be taken as cash.

## Payment of Gift

16. The Eligible Applicant who joins online will be sent a unique URL (**Reward Code**) within the Member Centre inbox linked to their Eligible Policy after the third (3) full calendar month from the date that the Eligible Applicant joins CBHS on an Eligible Policy (**Eligibility Date**). The Eligible Policy must not be in arrears at the date of the Eligibility Date to receive the Gift. For clarity, the Promoter will deliver Reward Codes to Eligible Applicants in monthly batches (once per calendar month), a full three months after the month the Eligible Applicant joins CBHS on an Eligible Policy.
17. The Eligible Applicant must claim and redeem their Gift within three (3) months after the date the Reward Code is sent otherwise it will be forfeited.
18. Following redemption of the Reward Code, GiftPay will fulfil the Gift in the form of e-gift card(s) to the Eligible Applicant which is accessed via the GiftPay website.

These Terms and Conditions must be read subject to those statutory provisions and will not affect any statutory rights that an entrant may have.
