# **CBHS GROUP TERMS AND CONDITIONS**

### CBHS Health Fund Limited and CBHS Corporate Health Pty Ltd CBHS Celebrate: All Extras Waits Waived Promotion

### **TERMS AND CONDITIONS:**

- 1. Information on how to enter and register for the CBHS Celebrate: All Extras Waits Waived Promotion (**Promotion**) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions. This Promotion is not valid in conjunction with any other offer.
- 2. The promoter is CBHS Health Fund Limited ABN 87 087 648 717 and CBHS Corporate Health Pty Ltd ABN 85 609 980 896 of Level 5, 79 George Street, Parramatta, NSW, 2150 (**Promoter** or **CBHS Group**).
- 3. The Promotion commences at 12.01 am (AEST) on 25 August 2016 and closes at 11.59 pm (AEST) on 31 August 2016 (**Promotion Period**) and may be extended.

## Definitions

- 4. For the purpose of these Terms and Conditions:
  - a. **CBHS Extras Cover** means Top Extras, Intermediate Extras, Essential Extras or extras associated with FlexiSaver Package, KickStart Package, StepUp Package or Prestige Package as defined in the CBHS Health Benefit Fund Rules;
  - b. **CBHS Corporate Health Extras Cover** means Gold Extras, Silver Extras or Bronze Extras as defined in the CBHS Corporate Health Benefit Fund Rules;
  - c. **CBHS Corporate Health Hospital Cover** means Gold Hospital, Silver Hospital and Bronze Hospital as defined in the CBHS Corporate Health Benefit Fund Rules;
  - d. **Current Member** means an existing member of the CBHS Group with a current, active policy with the CBHS Group;
  - e. Eligible Member has the meaning given in clause 8 of these Terms and Conditions;
  - f. Eligible Policy means;
    - i. any current, active policy with CBHS Health Fund Limited which includes CBHS Extras Cover and excludes Hospital only policies; and
    - ii. means any current, active policy with CBHS Corporate Health Pty Ltd which includes a combined cover of CBHS Corporate Health Extras Cover **AND** CBHS Corporate Health Hospital Cover.

# g. Extras Waiting Periods means;

- i. the two, six and twelve month waiting periods which apply to CBHS Extras Cover for CBHS Health Fund; and
- ii. the two and six month waiting periods which apply to CBHS Corporate Health Extras Cover for CBHS Corporate Health.
- h. **Immediate Family** means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin;

- i. Membership means a single, couple, family or sole parent membership.
- j. **Referring Member** has the meaning given in clause 12 of these Terms and Conditions; and
- k. Referring Member Gift means a cash payment in the sum of AUD \$100.00 for every Membership referred to the CBHS Group by a Referring Member during the Promotion Period.

# Eligibility

- 5. Entry is only open to residents of Australia aged 18 years or over.
- 6. Employees (and their Immediate Family) of the Promoter and the Promoter's associated companies; participating retailers; and, agencies associated with this Promotion, are ineligible to enter.
- 7. Entries submitted from outside Australia will not be considered.

## **The Promotion**

- 12. A Current Member who completes the steps set out in clause 11 is a Referring Member.

## **Referring Member Gift**

- 13. An Eligible Member can only be referred once. In the event an Eligible Member is referred more than once, only the first Referring Member to refer that Eligible Member will be eligible for the Referring Member Gift.
- 14. To be eligible to receive the Referring Member Gift, the Referring Member and Eligible Member's Eligible Policy must be active and paid up-todate for a period of 3 months after the Promotion Period ends.

### Waived Extras Waiting Periods

- 15. To be able to claim the waiver for Extras Waiting Periods, the Eligible Member must join either CBHS Health Fund Limited or CBHS Corporate Health Pty Ltd and commence payment of their Eligible Policy.
